### **Required Safety Equipment**

It is the responsibility of all anglers to have required state and federal safety equipment on board.

At time of inspection each morning, be prepared to display 1 life jacket for each angler; 1 throwable PFD; and, demonstrate functioning kill switch.

Inspection will be held during lineup for takeoff. Live wells must be empty.

Keep marine band radios on Channel 72 for tournament information and use Channel 16 for emergencies.

### **Fish Limits**

Fish size: 15 inches and over.

Teams are allowed to weigh a limit of five (5) fish per team, per day. Teams may have six (6) fish in the live well (three (3) per solo angler), but fish not being weighed must be released after you are done fishing and before making final run to weigh-in. **Culling is not legal**.

Any fish presented for weigh-in which fails to measure the official length limits shall accrue penalties at the rate of one (1) pound for each non-legal fish plus loss of the fish. An 8 ounce deduction will be made for each fish presented to the bump master for weighing that is determined to be non-releasable.

## **Boundaries**

<u>Wisconsin Waters:</u> Fishing is prohibited north of a line extending

from Gills Rock (N45\*17'38.9724", W-87\*1'23.0376")

to the Wisconsin state line and south of a line running from Brown County line (N44\*40'39.6210", W-87\*44'11.8026").

## Michigan Waters:

South of a line extending due east from Rochereau Point (N45\*18'13.92", W-87\*26'2.436") to the WI. State line.

All local, state and federal regulations apply.
