Fish size: 15 inches and over. Culling is not allowed. Teams are allowed to weigh a limit of five (5) fish per team, per day. No more than seven (7) fish in the live well. Fish not being weighed must be released before making final run to check-in. Any fish presented for weigh-in which fails to measure the official length limits shall accrue penalties at the rate of one (1) pound for each non-legal fish plus loss of the fish.
