(1) One team members <u>MUST</u> attend.</b></p> <p>All anglers must be off the water by 4:00 p.m. on the day of the rules meeting.</p>  | <p>Menekaunee Harbor<br/>Ogden Street<br/>Marinette, WI 54123</p> <p>Take-off will begin at 7:00 a.m. or first safe light.</p> <p>First flight due in at 3:00 p.m.</p> <p>5/15/20 Sunrise – 5:20 a.m.<br/>5/16/20 Sunrise – 5:19 a.m.</p>  | <p>It is the responsibility of all anglers to have required state and federal safety equipment on board.</p> <p>At time of inspection each morning, be prepared to display 1 life jacket for each angler; 1 throwable PFD; and, demonstrate functioning kill switch.</p> <p>Inspection will be held during lineup for takeoff. Live wells must be empty.</p> <p>Keep marine band radios on Channel 72 for tournament information and use Channel 16 for emergencies.</p>   |
| <u>Fish Limits</u>   | <u>Site Host</u>   | <u>Boundaries</u>  |
| <p>Fish size: 15 inches and over.</p> <p>Teams are allowed to weigh a limit of five (5) fish per team, per day. No more than seven (7) fish in the live well. Release any fish not being weighed prior to making your final run in. Culling is not allowed.</p> <p>Any fish presented for weigh-in which fails to measure the official length limits shall accrue penalties at the rate of one (1) pound for each non-legal fish plus loss of the fish. See page 2 for additional boundaries listed on boundary map from DNR.</b></p> <p>The tournament waters for this event shall be the Bay of Green Bay and shall include all rivers, creeks and canals connecting to the above-mentioned waters. Any waters within these boundaries posted "off limits" or "no fishing" by state or federal agencies will be off limit. Any live release areas established by the Tournament Director will be off limits. That as well as any additional off limits will be announced at the pre-tournament briefing. Only that water open to all public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. All local, state and federal regulations apply.</p> |

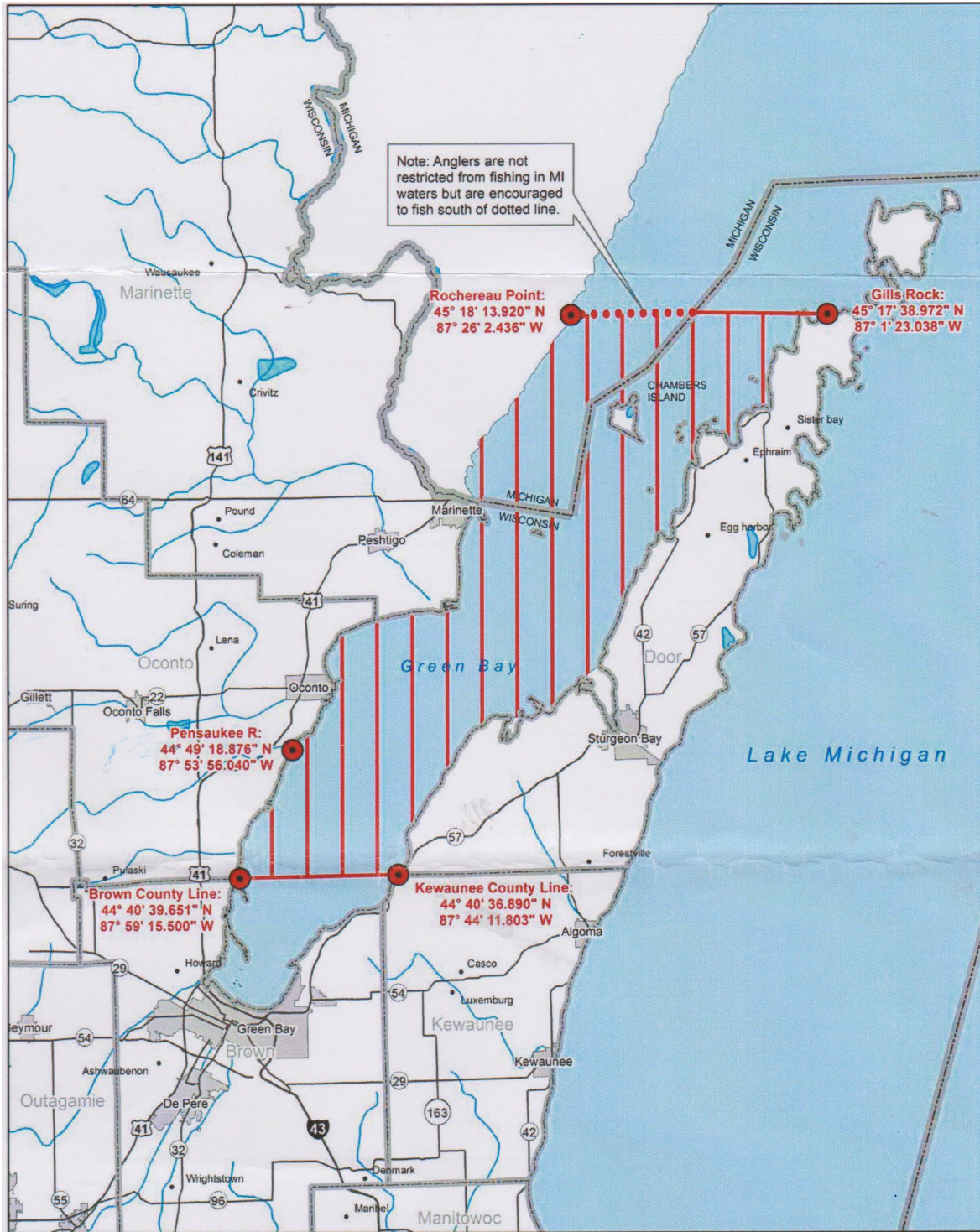
