<p><b><u>Registration/Rules Meeting</u></b></p> <p><b>Location:</b> Stony Point Resort – Game Room 5510 US 2 NW Cass Lake, MN. 56633</p> <p><b>Date:</b> Thursday, September 12, 2024</p> <p><b>Registration Times:</b> 4:00 p.m. – Registration Opens 5:00 p.m. – Registration Closes. <b>5:15 p.m. – Mandatory rules briefing begins. At least one (1) team member MUST attend.</b></p> <p>All anglers must be off the water by 4:00 p.m. on the day of the rules meeting.</p>	<p><b><u>Launch/Weigh-In</u></b></p> <p>Stony Point Resort</p> <p>Take-off will begin at 7:30 a.m. or first safe light.</p> <p>Weigh-In begins at 3:30 p.m.</p>	<p><b><u>Required Safety Equipment</u></b></p> <p>It is the responsibility of all anglers to have required state and federal safety equipment on board.</p> <p>At time of inspection each morning, be prepared to display 1 life jacket for each angler; 1 throwable PFD; and, demonstrate functioning kill switch.</p> <p>Inspection will be held during lineup for takeoff. Live wells must be empty.</p> <p>Keep marine band radios on Channel 72 for tournament information and use Channel 16 for emergencies.</p>
<p><b><u>Fish Limits</u></b></p> <p>Fish size: Walleye, 15 inch minimum.</p> <p>Teams may weigh five (5) fish per team, per day. Each angler is allowed one (1) fish over 20". No single angler may have more than five (5) fish in possession at any time. Release any fish not to be weighed in prior to making final run to check-in. <b>Culling is allowed.</b></p> <p>Any fish presented for weigh-in which fails to measure the official length limits shall accrue penalties at the rate of one (1) pound for each non-legal fish plus loss of the fish. Please call to make cabin or slip reservations</p>	<p><b><u>Boundaries</u></b></p> <p>Cass Lake Chain of Lakes (Cass Lake, Buck Lake, Lake Andrusia, Big Wolf Lake, Kitchi Lake, Pike Bay).</p> <p>The tournament waters for this event shall be Cass Lake and shall include all rivers, creeks and canals connecting to the abovementioned waters. Any waters within these boundaries posted "off Limit" or "no fishing" by state or federal agencies will be off limit. Any live release areas established by the Tournament Director will be off limits. That as well as any additional off limits will be announced at the pretournament briefing. Only that water open to all public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. All local, state and federal regulations apply.</p>
