4:00 p.m. – Registration Opens 5:00 p.m. – Registration Closes. 5:15 p.m. – Mandatory rules briefing begins. Atleastone (1) team member MUST attend.

All anglers must be off the water by 4:00 p.m. on the day of the rules meeting.

Launch/Weigh-In

Take-off will begin at 7:00 a.m. or first safe light.

Weigh-In begins at 3:15 p.m.

Required Safety Equipment

It is the responsibility of all anglers to have required state and federal safety equipment on board.

At time of inspection each morning, be prepared to display 1 life jacket for each angler; 1 throwable PFD; and, demonstrate functioning kill switch.

Inspection will be held during lineup for takeoff. Live wells must be empty.

Keep marine band radios on Channel 72 for tournament information and use Channel 16 for emergencies.

Fish Limits

Fish size: Walleye, Sauger and Saugeye 15 inches minimum.

Teams are allowed to weigh a limit of five (5) fish per team, per day. Each angler is allowed one (1) fish over 20". When the 8th fish goes into your live well you are done fishing for the day. Release any live fish not to be weighed-in prior to making final run to check-in. Culling (High-Grading) is not allowed.

Any fish presented for weigh-in which fails to measure the official length limits shall accrue penalties at the rate of one (1) pound for each non-legal fish plus loss of the fish. An 8-ounce deduction will be made for each fish presented to the bump master for weighing that is determined to be non-releasable.

Boundaries

The tournament waters for this event shall be the waters of Lake Francis Case and shall include all rivers, creeks and canals connecting to the above - mentioned waters. Any waters within boundaries posted "off limits" or "no fishing" by state or federal agencies will be off limit. Any live release areas established by the Tournament director will be off limits. That as well as any additional off limits will be announced at the pretournament briefing. Only water open to all public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. All local, state and federal regulations apply.
