<p><b><u>Pre-Event On-Site Check-In/Rules Meeting</u></b></p> <p><b><u>Location:</u></b> Port Clinton High School Performing Arts Center 821 Jefferson Street Port Clinton, Ohio 42453</p> <p><b><u>Date:</u></b> Thursday, April 10, 2025</p> <p><b><u>Mandatory On-site Check-in Times:</u></b> 3:00 p.m. – Check in Opens 5:00 p.m. – Check in Closes. <b>5:15 p.m. – Mandatory rules briefing begins. At least one (1) team member <u>MUST</u> attend.</b></p> <p>All anglers must be off the water by 3:00 p.m. on the day of the rules meeting.</p>	<p><b><u>Take-Off/Weigh-In</u></b></p> <p><b><u>Take-Off:</u></b> Jefferson Street Pier, Port Clinton, OH</p> <p>Take-off will begin at 7:00 a.m. or first safe light.</p> <p><b><u>Weigh-In:</u></b> Waterworks Park 205 E. Perry Steet, Port Clinton, OH 43452</p> <p>Weigh-In begins at 3:15 p.m.</p> <p>Anglers may use any launch they wish to unload and load their boat. You <b>MUST</b> trailer boat to weigh-in at Waterworks Park.</p>	<p><b><u>Required Safety Equipment</u></b></p> <p>It is the responsibility of all anglers to have required state and federal safety equipment on board.</p> <p>At time of inspection each morning, be prepared to display 1 life jacket for each angler; 1 throwable PFD; and, demonstrate functioning kill switch.</p> <p>Inspection will be held during lineup for takeoff. Live wells must be empty.</p> <p>Keep marine band radios on Channel 72 for tournament information and use Channel 16 for emergencies.</p>
<p><b><u>Fish Limits</u></b></p> <p>Fish size: Walleyes. 15 inches minimum.</p> <p>Weigh a max limit of five (5) fish per boat, per day. Release any live fish not to be weighed in prior to making final run to check-in. Culling is allowed.</p> <p>Any fish presented for weigh-in which fails to measure the official length limits shall accrue penalties at the rate of one (1) pound for each non-legal fish plus loss of the fish.</p>	<p><b><u>Site Hosts</u></b></p> <p>Port Clinton Area Chamber of Commerce <a href="http://www.portclintonchamber.com">www.portclintonchamber.com</a></p> <p><b><u>Host Hotel</u></b></p> <p>OurGuest Inn and Suites 220 E Perry Street Port Clinton, OH 43452 419-734-7111 <a href="http://www.ourguestinnsuites.com">www.ourguestinnsuites.com</a></p>	<p><b><u>Boundaries</u></b></p> <p>The tournament waters for this event shall be U.S. waters of Lake Erie and shall include all rivers, creeks and canals connecting to the above-mentioned waters. Any waters within these boundaries posted "off limits" or "no fishing" by state or federal agencies will be off limits. Any live release areas established by the Tournament Director will be off limits. That as well as any additional off limits will be announced at the pre-tournament briefing. Only that water open to all public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. All local, state and federal regulations apply. Canadian Waters are NOT open to fishing. Please follow all applicable laws and regulations.</p>
